## **Financial Obligations 2022-2023**

### **International Dues Assessment: Due October 2022, \$110.00**

This payment is passed on to Kiwanis International and funds the leadership training programs, insurance, Directors and Officers insurance, Magazine publication, and administrative expenses of the international organization. For new members, this amount shall be prorated according to the month in which the new member joins the club.

### **New Member Local Enrollment (One-Time)**

Each new member will pay a one-time new member fee of \$100.00 to the local club. Included in this fee, each new member will receive a name badge and Kiwanis shirt.

### **Club Semi-Annual Dues: \$90.00: Due October and March.**

The club dues are set annually by the club board of directors. Our dues pay for our leadership training and conference attendance, Key Club support, website maintenance and hosting, additional insurance, postage, administrative support, and other club expenses.

### **Weekly Club Lunch Meetings: Vero Beach Yacht Club, noon to 1 :00 pm, \$20.00 per lunch**

Attendance at lunch meetings is encouraged but is not mandatory. However, if a member does not attend lunch at least twice per month ("minimum lunches") October through May, then a charge of \$20 for each minimum lunch missed is added to the following quarter's membership dues. Lunch is usually buffet style meal with salad, a desert, iced tea, lemonade, and water. Gratuity is included.

### **Kiwaniis of Vero- Treasure Coast Charitable Foundation**

The club administers a charitable foundation. Our fundraising efforts are added to the foundation. The foundation is a qualified 501 (c)3 organization, and all donations are tax deductible in accordance with current federal tax law. We encourage all members to participate in our fund-raising efforts, whether by soliciting donations, donating time to support our fundraising events or by making a direct tax-deductible contribution to our foundation.

### **Social Events**

We do not include a social assessment to our local dues. Therefore, any club social events you attend are on a pay as you go basis. We generally try to hold a couple of social events in each half of the year. We found this is a fair way to approach social activities as typically not all members are available to attend each social event. Once again, you are only paying when you are able to participate.
